

# Trees for Rural Roads

## Guidelines & Application

Thank you for your interest in the Trees for Rural Roads program. Please carefully review the following guidelines and submit your completed application, along with the required supporting information, to the applicable Conservation Authority.

---

### Eligibility:

- The Trees for Rural Roads program is available to all rural residents.
- All Applicants will be notified of the results of the review of their application.
- Successful Applicants will be contacted in early April updating them on next steps.

### Requirements for Tree Planting:

- Trees must be planted along the property line on private property, adjacent to the roadway. Trees will not be provided to plant along Provincial roadways, private roads, unopened/unmaintained roads or in urban areas (Courtice, Bowmanville, Newcastle, and Orono).
- A 25 foot (8 metre) offset must be provided from power lines and other overhead or underground obstructions.
- A limited number of native shrub species are available where tree planting is not practical or feasible due to property constraints (E.g. hydro wires). Distribution will be at the discretion of the applicable Conservation Authority.
- The program allows the number of trees needed to plant one row along the roadway. The spacing requirement is one deciduous tree for every 40 feet (12 metres) of road frontage, and one evergreen tree for every 20 feet (6 metres) of road frontage.
- A maximum of 30 trees per year are allowed. Replacement trees as a result of mortality are also allowed.
- Tree planting and maintenance is the responsibility of the property owner.

### Additional Information:

- The program distributes small potted evergreen and bare-root and potted deciduous saplings (approximately three years old - size varies). This size is easier to transport and plant, and the growth will catch up to caliper stock over time.
  - Trees, tree guards for deciduous trees and mulch mats\* for all trees are provided for free. Planting instructions are also provided.
- \*Quantities may be limited.

## **Conditions**

Eligibility for involvement in "Trees for Rural Roads" may be limited by overhead or underground utilities, site lines, drainage, or suitability of planting site. Spacing and location will depend upon suitability of site for species requested, such as soil and drainage, location of existing trees on the property, etc.

Every effort will be made to inform the landowner in how they can increase the chances of survival and tree growth. It is understood that the survival of individual trees cannot be, and is not, guaranteed. The Applicant agrees to plant the trees adjacent to the road right-of-way on the property owners private property. Planting instructions will be provided. It is the responsibility of the landowner to ensure trees being planted do not in any way interfere with above and below ground utilities. The Trees for Rural Roads Program does not take any responsibility in the long-term care and maintenance of the trees planted under this program.
